### RULES AND REGULATIONS

1. **ENTRY PROCEDURE:** You must complete this form and return it to the sponsoring radio station before their deadline date.
2. **DISPUTES:** The sponsoring radio station is authorized to resolve all disputes at their Show. West Virginia Radio Corporation is the sole authority in resolving all disputes at any level competitions and to disqualify any contestant at any level of the contest for failure to comply with the rules and regulations including errors and omissions. WVRC decisions are final.
3. **GOOD CHARACTER:** The act agrees that it may be disqualified immediately if the act (or any member thereof) commits any act or becomes involved in any situation that would adversely effect on the show or any party furnishing a prize.
4. **PERFORMANCE:** The following applies to any Homegrown country contestant.
  - a. Each act entered in the show must perform only with the personnel listed on this entry form. No personnel changed or substitution will be permitted once the competition has begun.
  - b. Individuals may perform with only one act during any local show.
  - c. The radio station may, at it's discretion, provide a backup band for acts requiring instrumental support or allow contestants' pre-recorded music.
  - d. The amount of performance time given to each contestant will be determined by the radio station.
  - e. Each act must perform live, vocally and/or instrumentally. No special lighting, props or special effects may be used.
  - f. Any act with three or more individuals playing an instrument may not use the backup band or any part of the backup band, or pre-recorded music.

- g. All performances must be done in good taste. No music or lyrics the radio station considers to be offensive may be performed.
- h. Age restrictions will be at the discretion of the radio station and/or its venue.
- i. Contestants may perform their own music. Any contestant who claims to be using his own music may be disqualified at the discretion of WVRC if a musical copyright for the music exists which does not name the contestant as author or co-author.
- j. Acceptable documentation to prove ownership of your music shall include either a certificate of copyright, proof of song registration with BMI, ASCAP, etc. or a notarized copy of the application applying for the copyright with a signed statement by the contestant as to its status.
- k. Performances will be judged on the following: marketability in country music, vocal/instrumental ability, originality, stage presence/charisma, and talent.

5. **PROMOTIONAL AUTHORIZATION:** By submitting an entry form, the act grants to WVRC the right to utilize the act's (and each member thereof) name, likeness, image, voice, appearance, and performance in perpetuity worldwide for advertising, trade or any other lawful promotional purposes whatsoever, in any and all media now known or thereafter developed without compensation. I/we also grant WVRC the right to broadcast, market, sell and otherwise distribute my name, image, likeness, voice, appearance and performance, either in whole or in parts for commercial, non-commercial television, close-circuit exhibition, home video distribution, internet or any other purpose WVRC in their sole discretion may determine. I/we hereby give all clearance, copyright or otherwise for the use of my name, likeness, image, voice, appearance and performance embodied in my/out performance/stage presentation. If under 18 years of age, parent or guardian must sign the entry form.

6. **ASSUMPTION OF RISK:** By submitting this Entry Form, the act (and each member thereof) assumes all risks of property damage or bodily injury (including death) that might occur during the contest. The act (and each member thereof) agrees not to bring against WVRC or any sponsors any claim for property damage or bodily injury (including death) that might occur during the contest.

7. **ELIGIBILITY:** Submit any questions regarding eligibility to WVRC

- a. I am/we are not an act with over seven individuals
- b. I am/we are not part of the local backup band nor am I/we related to any member of local backup band by birth or marriage.
- c. I am/we are not an owner or employee of and I am/ we are not related by birth or marriage to any judge or any sponsor or anyone of WVRC.
